PRIVACY POLICY

Last updated: 5/22/2022

We take your privacy very seriously. Please read this privacy policy carefully as it contains important information on who we are, how and why we collect, store, use, and share your personal information. It also explains your rights in relation to your personal information and how to contact us or supervisory authorities in the event you have a complaint.

We collect, use and are responsible for certain personal information about you. When we do so we are subject to various laws in the United States, and we are responsible as "controller" of that personal information for the purposes of those laws.

2. Personal Information We Collect About You. We may collect and use the following personal information that identifies, relates to, describes, is reasonable capable of being associated with, or could reasonably be linked, directly or indirectly, with a particular consumer or household:

This personal information is required to provide products and/or services to you. If you do not provide personal information we ask for, it may delay or prevent us from providing products and/or services to you.

- **3.** How Your Personal Information is Collected. We collect most of this personal information directly from you—via our website forms. However, we may also collect information:
 - from our affiliates with your consent (*e.g.*, Full Cart); and
 - from our primary network partner via their application intake processes.

- 4. How and Why We Use Your Personal Information. Under data protection law, we can only use your personal information if we have a proper reason for doing so, *e.g.*,
 - to comply with our legal and regulatory obligations;
 - for the performance of our services with you or to take steps at your request before entering into a service agreement;
 - for our legitimate interests; or
 - where you have given consent.

A legitimate interest is when we have a business or commercial reason to use your information, so long as this is not overridden by your own rights and interests.

We will always treat your personal information with the utmost respect and never sell or share it with other organizations outside the U.S. Hunger group for marketing purposes.

We may ask you to confirm or update your marketing preferences if you instruct us to provide further products and/or services in the future, or if there are changes in the law, regulation, or the structure of our business.

- 6. Who We Share Your Personal Information With. We routinely share personal information with our affiliates. We may disclose and exchange information with law enforcement agencies and regulatory bodies to comply with our legal and regulatory obligations.
- 7. Personal Information We Sold or Disclosed for a Business Purpose. In the preceding 12 months, we have not sold to one or more third parties or disclosed for a business purpose to one or more third parties, any personal information that identifies, relates to, describes, is capable of being associated with, or could reasonably be linked, directly or indirectly, with a particular consumer or household.
- **8.** Where Your Personal Information is Held. Information is stored in encrypted databases that are hosted in Microsoft Azure Datacenters. Microsoft does not have access to our encrypted accounts.

- **9.** How Long Your Personal Information Will Be Kept. We will keep your personal information while you have an account with us or while we are providing products and/or services to you. Thereafter, we will keep your personal information for as long as is necessary:
 - to respond to any questions, complaints or claims made by you or on your behalf;
 - to show that we treated you fairly; or
 - to keep records required by law.

We will not retain your personal information for longer than necessary for the purposes set out in this policy. Different retention periods apply for different types of personal information.

Our website and its servers are operated in the United States, and regardless of your place of residence, your use of our website is governed by the laws of the United States. Those processing your information will do so only in an authorized manner and are subject to a duty of confidentiality. We also have procedures in place to deal with any suspected data security breach. We will notify you and any applicable regulator of a suspected data security breach where we are legally required to do so.

Any personal information we collect from you to verify your identity in connection with you request will be used solely for the purposes of verification.
